### Dues Payment Schedule

You may pay your dues in full, quarterly (January/April/July/October), or in 12 equal payments. Choosing the quarterly or monthly option online will enroll you in autopay to ensure your credit card information remains secure and is not retained by IOA. If your card on file expires this year, please contact the IOA with the new expiration date.*

### Change in Membership Classification

The AOA allows members to change their membership classification only once during a membership year. **The change must be submitted between January 1 and March 31.** Changes requested before March 31 will be retroactively applied and will become effective at the beginning of the current membership year. Any change requests received after March 31 will become effective on January 1 of the following year.

### Lobbying Tax Deductibility for 2025

Dues payments made to the IOA and AOA may be tax deductible as ordinary and necessary business expenses subject to restrictions imposed because of association lobbying activities. The AOA estimates that the nondeductible portion of your AOA 2025 dues, the portion that is allocable to lobbying and political activities, is 12%. The Indiana Optometric Association’s nondeductible portion of your 2025 IOA dues is estimated to be 5%.
